

## **Privacy Policy**

VEE Technology LLC, a Cayman Islands company, located at Floor 4, Willow House, Cricket Square, P O Box 2804, Grand Cayman KY1-1112, Cayman Islands (the "Company," "we" or "us") is committed to protecting and respecting your privacy.

This Privacy Policy (together with the Terms of Use and any other document referred to it) governs the manner in which the Company collects, uses, maintains and discloses any personal data collected from you, or provided by you to us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it. By visiting [www.VEE.money](http://www.VEE.money) (the "Website"), you are accepting and consenting to the practices ascribed in this Privacy Policy.

This Privacy Policy applies to the Website and all the services offered by us.

### **What Information Do We Collect?**

When you visit the Website, you may provide us with two types of information: personal information that you voluntarily disclose that is collected on an individual basis; and non-personal information collected automatically when you use the Website or the services available on the Website (collectively, the "Information").

### **Collection of Personal Information**

Personal information is collected from you by filling in forms on the Website, or by corresponding with us by e-mail or otherwise. ### **Collection of Non-Personal Information**

We may collect non-personal identification information of yours whenever you interact with the Website. Non-personal identification information may include, without limitation, the following information:

- Server Log Information, including, without limitation, your login details, the date and time of visits, the pages viewed, your IP address, time spent at the Website and the websites you visit just before and after the Website;
- Device Information, including, without limitation, the computer or mobile device you use to access the Website, including the hardware model, operating system and version, the web browser you use, and other device identifiers;
- Telemetry Information, including, without limitation, bandwidth upload and download speeds, the amount of free and used storage space on your device and other statistics about your device, if you use any of our open source software.

## **Cookies and Other Technologies**

We use various technologies to collect information when you interact with the Website, including cookies and web beacons. This helps us to provide you with a good experience when you browse the Website and also allows us to improve the Website. By continuing to browse the Website, you agree to our use of cookies. Cookies are small data files that are stored on your device when you visit a website, which enable us to collect information about your device identifiers, IP address, web browsers used to access the Website, pages or features viewed, time spent on pages and links clicked. Web beacons are graphic images that are placed on a website or in an email that is used to monitor the behavior of the user visiting the website or sending the email. They are often used in combination with cookies.

If you want to disable cookies, you can block cookies by activating the setting on your browser that allows you to refuse the setting of all or some cookies. Please note that certain features of the Website will not be available once cookies are disabled.

## **Use of Information**

We may collect and use information for the following purposes:

- improve customer service: analyzing and tracking data to determine the usefulness or popularity of certain content and to better understand the online activity of the Website users and support their needs more efficiently;
- improve the Website: providing, maintaining, delivering or improving the Website or the services provided on the Website;
- regulatory requirements: fulfilling the legal or regulatory requirements, detecting, investigating and preventing unauthorized or illegal activities and protecting the rights and interests of yours.

## **Sharing of Information**

You agree that we have the right to share your personal information with selected third

parties including:

- 1) our current or future parent companies, affiliates, subsidiaries and with other companies under common control or ownership with us or our offices internationally;
- 2) third parties or service providers that work for us; and
- 3) government department that asks us to provide.

You agree that we have the right to share your personal information in case:

- 1) we sell or buy any business or assets, in which case we may need to disclose your personal data to the prospective seller or buyer of such business or assets;
- 2) the Company or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets;
- 3) we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in accordance with the Terms of Use;
- 4) we believe your actions are inconsistent with the Terms of Use, or to protect the rights, property, or safety of the Company or others;
- 5) where aggregate Information is disclosed which cannot be reasonably used to identify you.

### **Protection of Personal Information**

We take reasonable steps to protect against unauthorized access, alteration, disclosure or destruction of your personal information and data stored on the Website, yet we will not be held responsible for any unauthorized access or use of the data, and we cannot and do not guarantee that information of yours will not be altered before or after its transmission to us. You agree to not hold us and our employees, officers, directors, contractors, consultants, equity holders, suppliers, vendors, service providers, parent companies, subsidiaries, affiliates, agents, representatives, predecessors, successors and assigns liable for any loss or damage of any sort incurred as a result of any misappropriation, interception, modification, deletion, destruction or use of information provided through the Website.
